New intake cards were designed to help direct students from the beginning of the intake process. RAP (Recovery Action Plan) sheets were designed to allow Counselors to write notes and an action plan to assist a student towards academic success. RAP sheets were signed by students and acted as an informal contract. RAP sheets are scanned and available to counselors to reference when meeting with a student. Follow up letters and emails were sent to all students on Probation midway through the semester to check in to see if they were having any difficulties during the semester. Statistics of the number of students who came in person to see a counselor are currently unavailable due to departmental and staffing changes.
