

**BERGEN COMMUNITY COLLEGE  
AND  
SAINT PETER'S UNIVERSITY OFF-SITE CAMPUS AGREEMENT**

Bergen County Community College (BCC students) and Saint Peter's University (Saint Peter's) agree to work together to provide degree completion courses to BCC students at the BCC site located in Lyndhurst, NJ (Lyndhurst).

**COURSE OFFERINGS**

Programs. Saint Peter's would offer the BSBA with management, marketing and healthcare concentrations with an option for an accelerated MBA to be offered on site to students meeting certain academic requirements. New programs will be added at the discretion and with the agreement of both parties.

Course Planning. Course would be selected by Saint Peter's in consultation with active degree candidates.

Course Schedules. Each course would be offered on a mutually agreed- upon schedule one night per week between 6 and 9pm in 8-week sessions.

Enrollment. BCC students will have first preference to all courses offered at Lyndhurst. Saint Peter's will provide a course roster if requested for any non-BCC students that will be attending the course.

**ADMINISTRATION**

The following administrative guidelines are provided:

Admissions, Advising and Registration. These activities would take place on a continuous year-round basis. In addition, Saint Peter's will hold on-site advising and registration prior to each trimester. Admissions decisions are based on individual cases. BCC will assist in promoting the program and events.

Administration. Elizabeth Kane, Dean of SPCS, will serve as liaison for programs and curricula at Lyndhurst. In addition; an adviser will be assigned to Lyndhurst students and will maintain an office at the site.

**FINANCIAL ARRANGEMENTS**

The financial arrangements for the program are as follows:


Billing and Payment. All billing and tuition will take place directly between Saint Peter's and the students.

Scholarship and Grants. Saint Peter's will award a community college grant to all graduates of BCC.






