Dean Victor Brown, of the Division of Business, Arts and Social Sciences, has joined the Senate, replacing Dr. Naydeen Gonzalez – de Jesus.

VI. OLD BUSINESS

Brian Cordell spoke, again, about the proposed implementation of IST-123 (Student Success 101), still a pilot course. He asked for the Senate to discuss and present ideas. A full discussion of about I/2 hour, ensued.

VII. NEW BUSINESS

Dr. Kaufman and Dr. Yun Kim are co-chairing a committee charged by President Walter to design a policy for the deletion of courses/academic options that have not run successfully for several years. When the committee has completed its work it will be presented before the Curriculum Committee and then, if the proposal is approved, the Faculty Senate.

Guest Francis Schmidt asked for a Senate resolution about the primary role of information technology in the classroom. Schmidt indicated that he was looking for clarification of the line between academics and administration of IT. There was vigorous discussion, with feedback from many Senators and guests, including Stephen Valkenburg, Executive Director of Information Technology, and Chief Corcoran. Professor Gregg Biermann made a motion that "technology should support the mission of teaching and learning at the college".) (The motion passed 42-0-0). Professor Anita Verno suggested that the Technology Governance Committee (-a committee from 10 years ago, made up of_IT, faculty, staff, library) be recreated to meet and discuss hardware and software issues as the affect academics. The committee will be organized by IT. (The motion passed 43-0-0)

Members of the Math Department expressed concern about the rigor of courses being offered by the Weekend College. Dr. Mullaney responded that, at the end of the semester, there will be review/surveys/discussions about all aspects of the Weekend College. He was asked if full-time faculty are able to teach these courses as part of their regular course load and he said yes.

Dr. Stacey Balkan moved that the Senate formally call on BCC to decry hate crimes and declare itself a sanctuary college. A motion was made: BCC declare ourselves a sanctuary college and affirm that the college does not tolerate hate crimes. (The motion passed: 36-0-0).
