Jack Kent Cooke Foundation

President Friedman announced the wonderful news that Bergen Community College has four 2021 Jack Kent Cooke Foundation Undergraduate Transfer Scholars. The following students were selected: Bekim Bruka, Genesis Capellan, Ignacio Leon, and Laila Metwaly.

The students will receive up to \$40,000 per year toward tuition, living expenses, books, and required fees to complete their bachelor's degree.

Nursing Program accreditation

Dr. Friedman congratulated Dr. Susan Barnard and her team in Health Professions on a mark of excellence accomplishment; they have received notice of the reaffirmation of their specialized accreditation from the Accreditation Commission for Education in Nursing.

Dr. Ilene Kleinman

Dr. Friedman congratulated Dr. Ilene Kleinman for being chosen as a Middle States Commission on Higher Education Peer Evaluator for Delaware County Community College.

State of the College

President Friedman has been at Bergen for four months and completed his 90-day listening tour, which became an extended 120-day listening tour. As a result of the information gathered during the listening tour, he stated that the College is at a real turning point. He recommended building on the college's successes while continuing to innovate in how we meet the needs of our communities. The business and industry sectors are ready to partner with Bergen; the students expect support and guidance and holistic services. This is an incredible moment of opportunity and he is proud to lead and move all of Bergen's community members up and forward.

Enrollment

The Summer 2 and Summer 3 enrollment numbers are ahead compared to last year, with a 4.5% increase in the number of students enrolled and a 9.9% increase in the number of credits registered to date. Summer 2 and 3 are the first semesters in the new fiscal year. Dr. Friedman reported that quarantines were managed well, the Bergen community was kept safe, and the fall semester will have additional in-person classes as the College transitions back.

Reopening

President Friedman and Dr. Hlavenka will present the revised reopening plan to the May board committee meetings for adoption at the June board meeting. The additional sections to the fall academic schedule will be split between remote, hybrid, and on-the-ground offerings. Dr. Fisher will not approve any additional asynchronous online course sections. The plan will be to focus on increasing our on-ground presence and phasing in additional services within the coming weeks.

Presidential Goals

At the May Board committee meetings, President Friedman will present his 2021-2022 Presidential Goals for adoption at the June board meeting. The goals include, but aren't limited to, the following areas:

- strategic enrollment management
- renewed college-wide focus on student success
- clarifying the systems and processes of participatory and shared governance
- supporting efforts to clarify, and make increasingly visible, the College's fully online offerings (which is different from remote offerings) while promoting continuous improvement and growth in the portfolio of BCC's fully online offerings.
- to further define, strengthen and develop diversity, inclusion, and equity initiatives and policies.
- leading and supporting efforts to establish a vision and path forward for off-campus sites.
- leading and supporting efforts to position the College as a recognized hubsite for post-COVID economic recovery while leveraging the strengths of partners.
- leading and supporting the development and implementation of initiatives related to the College's visibility, its story-telling out in the community, and the public's awareness of its amazing programs and services.
- leading renewed emphasis on improvements in the aesthetic environment; evaluating current spaces for their effectiveness in realizing their intended purpose.

High School Partnerships

Bergen has a nationally distinctive, strategic partnership with The Applied Tech High School. Superintendent Lerner provided the following statistics:

"Our first program, Engineering Technology (Mechatronics) presently has 120 students, Health Professions has 90 students, and our newest program, Cyber Security has accepted 30 students into their first 9th grade class for September 2021. And 47 students out of 82 who graduated from the Engineering Technology high school program, at the same time, graduated with their associate's degree."

Dr. Friedman will continue to support success in these programs.

Industry partnerships

President Friedman visited BCC's partner, at Volvo Cars. This partnership is a best-practices example of a community college establishing a beneficial relationship with a corporate partner. Bergen's culinary grads are working for Volvo, a BCC adjunct instructor was selected by Volvo to be their Executive Chef, and Ronda Drakeford, faculty member and coordinator, is teaching her students in a live, business environment. Everyone Dr. Friedman interacted with during his visit was overjoyed about the partnership and loved what Bergen was doing to provide wholesome, nutritious, high-quality meals for Volvo's employees and guests.

These examples of strategic partnerships will be a key part of defining BCC in the years to come. The college will need to do everything it can do to work with industry partners at every opportunity. Dr. Hlavenka and Dr. Friedman are working with the County of Bergen's communications team, as well as the County Commissioners who have communications portals, to leverage the strengths of their communications departments. The goal is to show ALL of Bergen's communities the success stories, the partnerships, curricular innovations, and incredible value that this great community college represents.

Economic Recovery Committee

At the inaugural Economic Recovery Committee meeting, the committee's charges were defined and it heard a comprehensive overview of New Jersey's labor profile from BCC's partners at the New Jersey Business & Industry Association. The launch of that committee is a great step forward in positioning BCC at the center of the region's economic recovery efforts. A big thank you to Chairwoman Blakeslee for joining the first meeting and supporting the efforts.

Humanities Connections grant - Professors Eileen Fitzgerald and Richard Kuiters

President Friedman was inspired by Professors Eileen Fitzgerald and Richard Kuiters in relation to the Humanities Connections grant that they have been overseeing. Bergen was the only community college to be awarded this \$35,000 planning grant from the National Endowment on the Humanities. The goals of their efforts were to prepare criminal justice students to engage in the academic abilities required for bachelor degree programs; infuse future law enforcement professionals with a broader, humanistic and social justice perspective that will allow them to better serve the community; and foster collaborative conversations about the justice system among students, faculty, and community.

Beacon Conference - student Katie Conte

Bergen Community College student Katie Conte was chosen to present her paper, "The Crisis America's Youth is Facing as a Result of COVID-19," at the prestigious 29th Beacon Conference for Student Scholars. Bergen is so proud of Katie as she embraces many academic opportunities that come her way.
