Election Timeline

Election Information Sessions:

The Elections Committee will discuss and answer questions about the timeline, rules, and guidelines of the election. Candidates will be provided with the Elections Guidelines. These will take place through WebEx and be organized and promoted by the SGA Chief Justice and Elections Committee.

Application (3-week period):

Thursday, March 26, 2020 @ 9:00 AM (open)

Thursday, April 16, 2020 @ 4:00 PM (close)

The applications for each executive board position will be available online to be filled out and submitted. The form can be found at www.bergen.edu/sga. All materials must be submitted by the above due date. No exceptions will be made if submitted late.

By 12:00 PM on Friday, April 17, 2020, all candidates will have received confirmation of whether or not they are eligible to run for the respective positions they each declared candidacy for. Please note that our advisors will be checking each candidate's grades and social standing. All personal information will be strictly confidential and only known by the SGA advisors.

Elections, and Announcements:

Election Days

Monday, April 20, 2020 @ 8:00 AM - Friday, April 24, 2020 @ 5:00 PM

During this period, currently enrolled students of Bergen Community College may actively vote for candidates in the elections. Candidates are allowed to campaign for themselves during this week; however, there are a few locations that are "neutral zones" (i.e. off limits) that candidates are not allowed to loiter near while campaigning. Please use reasonable judgement in this process.

Appeals

Saturday, April 25, 2020 - Monday, April 27, 2020 @ 8:00 AM

Appeals must be completed using the Elections Appeal form which will be emailed out to all candidates at the conclusion of the election period. Candidates will have the opportunity to bring forth appeals to SGA Advisor Ian Wolf, at this and only this time. In the event that an appeal against a candidate is deemed appropriate and viable, the SGA Advising Team in conjunction with the Elections Committee may expel the candidate in question from the election. Appeals will be reviewed in a timely fashion. At this meeting, the Elections Committee will certify the election results.

Announcements

Tuesday, April 28th, 2020

Election results will be announced via email and the new Executive Board will be announced on the SGA's Social Media accounts once the appeals process has been completed. The incoming SGA Executive Board will be introduced to the student body when normal operations and on-campus activities resume.

Rules and Regulations

Eligibility:

All candidates must be any credit bearing students and must maintain that status for the 2020 - 2021 academic year. Any candidate on Academic or Disciplinary Probation (As defined by the college) is prohibited from contesting or occupying a position within the SGA. All candidates must have a minimum 3.0 GPA.

Responsibilities:

Each candidate interested in running is required to fill out the application packet made available online on **Thursday, March 26, 2020**.

Each candidate is responsible of completing all parts of the application including:

- Online Application
 - Resume
 - 500-word maximum essay (12 point font, Times New Roman font, and double spaced) on why you are interested in running, goals/initiatives for 2020-2021 academic term, and why you are the best candidate suited for this position
 - Picture or Headshot
 - 2-minute maximum video on why you are running for a leadership role and how the SGA can help students get through COVID-19 or related experiences.
 - Candidate bio limited to 280 characters
- Optional Campaign Instagram Post
 - Candidates have the option to send in a created Instagram post that the SGA and the Office of Student Life & Conduct will host during Election Week.

Candidates are responsible if elected to attend all SGA related meetings. These include but are not limited to:

- Exec Board and Advisor Meetings: Mondays @ 12:30 - 1:30 PM
- Full SGA Meetings: Wednesdays @ 12:30 - 1:30 PM
- Executive Board Meetings: Tuesday or Thursdays @ 12:30 - 1:30PM

- **Chief Justice Only** Breathe Clear Campus Club involvement
 - This will be determined under the guidance of the SGA Advising Team
- **President and Vice President Only** Monthly Board of Trustees and Faculty Senate Meetings:

Additionally, each candidate that is elected into an Executive Board position must attend a training retreat on **Monday, May 11, 2020** and **Tuesday, May 12, 2020**. Expect the training times to run from 9 AM to 3 PM. This is subject to change given the college's action regarding COVID-19.

Neutrality of Elections Committee:

All members of the Elections Committee are forbidden from publicly endorsing and actively campaigning on behalf of any candidate from the beginning of their tenure on the Elections Committee until the announcement of the results. Managers of Election Polling Locations are forbidden from publicly endorsing and actively campaigning on behalf of any candidate during the time of active campaigning and elections. Any violations of this commitment to neutrality will result in an investigation by the SGA advisors.

The Election Committee is chaired by Robin Yoo. Other members of the committee are Ariana Fernandez, David Johansson, Steven Machuca, and Alexios "Blaise" Rossman. The Elections Committee is advised by Ian Wolf.
